INFORMATION FOR THE PROCESSING OF PERSONAL DATA (pursuant to European Regulation 679/2016)

The Libertas National Sports Center (hereinafter also "C.N.S. Libertas" or "Il Centro"), with registered office in via Po, 22, 00198 Rome RM, Italy, C.F. 8023 VAT number 04030581005, as owner of the processing of your personal data (hereinafter "Owner"), informs you, pursuant to art. 13 EU Regulation no. 679/2016 (hereinafter, "Regulation") that the personal data you voluntarily make available to the Centro Nazionale Sportivo Libertas will be processed in compliance with current legislation on the protection of personal data and, in any case, the principles of confidentiality which inspired the activity of the Center.

1. Purpose and legal basis of the processing

Your personal data will be processed (for the definition of 'processing', see Article 4, paragraph 2 of the Regulation) for the following purposes:

- a) execution of membership activities;
- b) organization and management of competitions and sporting events and / or regional, national and international sporting events;
- c) execution of the activities related to the relationship established with the membership including activities related to the management of relations with insurance companies;
- d) related obligations:
 - to obligations established by the law, by the regulations, by the statute and by the regulations of the Center and, in general, by the legislation applicable from time both nationally and internationally;
 - the inclusion in the systems of the Center of the personal data of athletes, managers, coaches, referees, technicians;
 - sending institutional communications;
- e) dissemination of images and video footage acquired during the registration phase, during training, and / or during competitions or sporting events directly or indirectly organized and / or authorized by the Center itself, for institutional, promotional and advertising purposes relating to the activities of the Center, their publication on existing or subsequently created social networks, as well as on proprietary web portals;
- f) transfer to third parties (by way of example partners of the Center) for the sending of information, including commercial, on the services offered or future offered by such third parties.

The legal basis of the processing is identified (by way of example) in the granting of consent to the processing of data.

2. Personal data being processed

2.1 Personal data

In particular, the personal data in question concern:

- Name, address or other elements of personal identification of you and your family, including your image and possibly the details of your bank account (com

2.2 Special categories of personal data ("sensitive data")

It may happen that the Center, in the execution of its activities and in the pursuit of the purposes listed above, comes to treat particular categories of data, such as suitable for revealing racial and ethnic origin, health data, religious beliefs, trade union membership, anthropometric data intended to uniquely identify you as well as personal data suitable for revealing the state of health, sexual orientation, for the processing of which your written consent is required.

3. Data retention times

The data concerning you will be stored according to the following criteria:

- for a period of time not exceeding that necessary to achieve the purposes for which they are processed;
- for a period of time not exceeding that necessary for the fulfillment of regulatory obligations.

4. Methods of use of data

The processing of your personal data will be carried out using suitable paper, electronic and / or telematic tools, with logic strictly related to the aforementioned purposes and, in any case, in such a way as to guarantee the security and confidentiality of the data.

In accordance with current legislation, specific security measures are observed to prevent the loss of data, illicit or incorrect use and unauthorized access. You are kept for a period consistent with the purposes for which they are collected.

5. Scope of data circulation

The members, the members of the Offices of the Center, the Commissions, the Regional and Provincial Committees or National Sports Federations and Association Sports Disciplines, the Italian National Olympic Committee (CONI), CONI Servizi S.p.A. may have access to your personal data. or other national and international sports body and, in any case, the managers - external - designated by the Center and those authorized to process personal data appointed by the Center in the exercise of their functions.

Your personal data may be disclosed to any persons who provide the Center with performance or services instrumental to the purposes indicated above such as for example, to credit institutions, professional firms, suppliers / consultants who manage and / or participate in the management and / or the maintenance of the electronic and / or telematic tools used by us, insurance companies for the provision of insurance services, bodies, companies or subjects with which the Center has relationships for the organization or management of sporting events, advertising or sponsorship of events, tournaments or sporting events, data processing activities of commercial activity of sale and / or supply of goods and / or advertising services in the context of promotional and marketing commercial activities (referred to in paragraph 1 of this information) for the time strictly necessary for the optimal execution of this service.

Your personal data will be made accessible only to those who, within the Center, need it in relation to the exercise of their duties or hierarchical position. The subjects will be properly instructed in order to avoid loss, destruction, unauthorized access or unauthorized processing of the data.

Without your express consent (pursuant to Article 6 letter b) and c) of the Regulation), the Data Controller may communicate your data to supervisory bodies and authorities as well as to all other subjects to whom communication is mandatory on the basis of an express provision of law.



6. Nature of the provision

With reference to the purposes highlighted in paragraph 1. "Purpose and legal basis of the processing":

- letter (c) would prevent the execution of activities related to the relationship established with the membership including activities related to the management relations with insurance;
- letter (d), would prevent the fulfillment of obligations provided for by the law, regulations, statute and regulations of the Center and, in general, by the legislation applicable from time to time both nationally and internationally and the inclusion in systems of the Center for the registry of athletes, managers, coaches, referees technicians.

Your possible refusal and / or the provision of incorrect and / or incomplete information with reference to:

- letter (e) would prevent the dissemination of images and video footage acquired during the registration phase, during training, and / or during competitions or sports events directly or indirectly organized and / or authorized by the Center itself, for institutional, promotional and advertising relating to the activities of the Center through publication on existing social networks or even subsequently created, as well as on proprietary web portals;
- letter (f) would prevent the transfer to third parties (by way of example partners of the Center) for the sending of information, including commercial ones, or services offered or future initiatives, by such third parties.

7. Dissemination of data

Your data will not be disclosed to indeterminate subjects.

8. Transfer of data abroad

For needs strictly related to the pursuit of the aforementioned purposes (for example, participation in competitions or international sporting events and entry procedures in the relative non-EU host countries), some of your personal data may be transferred to countries and / or organizations outside the EU. .

In this case, the Data Controller hereby ensures that the transfer of non-EU data will take place in accordance with Articles 44 ff. of the Regulations and the applicable legal provisions by stipulating, if necessary, agreements that guarantee an adequate level of protection.

10. Exercise of rights

We inform you that at any time with regard to your data, you can exercise the rights provided within the limits and under the conditions set out in articles 15-22 of the GDPR 2016/679.

We inform you that the Center undertakes to respond to your requests at the latest within one month of receiving the request. This deadline could be extended depending on the complexity or number of requests. The Center will explain the reason for the extension to you within one month of your request.

In detail, the interested party has the right to:

- ask the Data Controller for access, correction or cancellation ("Right to be forgotten") of personal data or the limitation of the processing of personal data concerning him or to oppose their treatment;
- obtain data portability;
- propose a complaint to a supervisory authority.
